TERMS OF USE

1. USER'S ACCOUNT

The use of the Services requires the creation of a MyCobiotx account through a specific registration process. To create a MyCobiotx account, the User as appointed by the Customer, will first receive an email from MyCobiotxcom to invite the User to click on the button "Link my account". 2. USE OF THE SERVICES

- **2.1.** Subject to the subscription of the Services by the Customer and the User's compliance with the Terms of Use, Aldebaran grants the User a limited, personal, non-exclusive, revocable, non-assignable and non-transferable right to access and use the Services through the Site.
